This allows graduates to seamlessly convert their FAA license to an Indian DGCA Commercial Pilot License, paving the way for a smooth transition to flying professionally in India.

Duration:

- Duration: 12 months

Please note:

This self-paced course's duration varies based on individual factors like aptitude, attendance, and weather. Students enrolled in this course receive an initial I-20 valid for 12 months. Those surpassing the 12-month timeframe will be required to extend their I-20, and any associated extension fees will be the responsibility of the student.

Stages of the Course: Certificates and Ratings, completed in order:

1. Private Pilot
2. Instrument Rating
3. Commercial Pilot – Single-Engine and Multi-Engine

Getting Started with Your Course:

Upon your arrival at our school in the US, your orientation will be conducted, and all necessary paperwork, including your TSA/AFSP application, Your FAA Medical examination application will be completed, and your appointment will be scheduled. Additionally, your first flight experience at our school will be scheduled as a discovery flight with an instructor.

12. Airport Landing Fees: Some airports may charge a landing fee when a student aircraft lands there. These fees are not included in the course price and must be paid directly by the student to the respective airport authority.
13. External Aviation Charges: Any future charges, fees, or costs imposed by external aviation organizations, airports, or regulatory bodies that are outside the control of the flight school are not included in the course price. Students are responsible for paying such expenses directly as they arise.



Dual and solo flight time may vary depending on student aptitude, proficiency, and Airman Certification Standards; therefore, only the minimum aeronautical experience is included, and any additional hours required will be charged at current rates. Any variation or change to the course structure will result in a price adjustment, with ground and flight instruction billed at \$90/hr in addition to aircraft charges. Flight training requiring a Certified Flight Instructor (CFI) will be charged at the dual rate, while solo flights and PIC crew time building (including safety pilot time) will be billed at the solo rate. Ground instruction includes unlimited scheduled group ground school and limited one-on-one sessions (25 hrs each for PPL & IRA, 10 hrs each for CPL SE & ME, total 70 hrs), with additional hours charged at current rates. PIC crew time building is 90 hrs (40 hrs cross-country PIC and 50 hrs PIC). The flight hours listed reflect syllabus and regulatory minimums; actual time may vary and additional hours will be charged at current rates. Flight training may also be delayed due to ATC, weather, or examiner availability, for which the school is not liable, and any associated costs will be the student's responsibility. Course pricing excludes aircraft dispatcher course fees, which may be added separately.

This is a self-paced course and duration depends on aptitude, attendance, and weather. International students cannot extend their I-20 beyond 12 months unless they have completed PPL, Instrument Rating ground school with FAA knowledge exam, and CPL ground school with FAA knowledge exam. Maximum time allowed to complete the course is 24 months; beyond this period, the course will automatically terminate without refund, and any remaining credit will be forfeited. The discounted course price is valid for twelve (12) months from commencement; any incomplete portion thereafter will be billed at standard rates. Any modification or deviation from the original structure, schedule, or payment plan nullifies the discount, which is contingent on the original payment option selected. Course prices are subject to adjustment due to increases in fuel, maintenance, regulatory compliance, or operational costs beyond the school's control, and the school reserves the right to revise hourly flight and ground instruction rates. Unless required by extraordinary circumstances, such adjustments will ordinarily take effect on January 1 each year, and all revised rates will apply automatically from their effective date.

Discounted course fees are available only under the payment options specified in the course details, and all tuition fees once paid are non-refundable. Once ground or flight training commences, the full course fee becomes chargeable to the student. The tuition fee covers only the prescribed minimum training hours—including solo, dual, crew, and time-building—as outlined in the official course details. These minimum hours are fixed for each stage of training, such as PPL, IRA, CPL/ASEL, and CPL/AMEL/IRA, are determined by the school, and cannot be altered at any time. Each course is allocated a fixed structure of hours, including specific solo, dual, and crew time, and this structure cannot be changed. If a student exceeds the solo or dual allocation in one segment (e.g., PPL), they may use any remaining allocation of the same type from another segment (e.g., IRA or CPL/ASEL). Once all allocated solo, dual, or crew hours for the entire course are utilized, any additional training will require separate payment. Flight hour credits are not interchangeable; for example, unused multi-engine dual cannot be applied to single-engine dual, and unused solo or crew time cannot be converted to dual hours.

Any additional hours required beyond the total allocation must be purchased in advance in blocks of five hours at the prevailing rate. If more than one five-hour block is realistically required for course completion, this will be discussed with the student, and larger block payments may be authorized by the school. Credits from additional five-hour payments may be carried forward to subsequent stages of training. Upon completion of the full course, any remaining credit may be used for additional solo or dual hours within sixty days of course completion, after which any unused credit will automatically lapse. Flying will only be permitted once the required additional payments have been made.

Our flight school offers training at heavily discounted rates; therefore, the validity of the course and any credits purchased for flight training is limited to a specified time period only. Tuition fees paid towards the course, along with the allocated flight hours, must be fully utilized within twenty-four months of enrolment. After this period, any remaining credit of flight hours will automatically lapse, be reduced to zero, and stand forfeited. If training is required beyond the twenty-four-month period after the allocated hours have expired, additional hours must be purchased in advance. Such additional hours will be available in blocks of five hours at the prevailing rate. If it is realistically determined that more than one five-hour block will be required for course completion, the school will discuss the requirement with the student, and larger block payments may be authorized.



COMMERCIAL PILOT LICENSE Admission Process



Admission Requirements:

To enroll in our training program, you need to meet the following prerequisites:

1. To begin flight training, you must be at least 17 years of age.
2. To take the oral and practical test for the Commercial Pilot Course, you must be at least 18 years of age.
3. You must be able to read, speak, write, and understand the English language fluently.
4. You should obtain at least a First-class medical certificate from an Aviation Medical Examiner.

Meeting these prerequisites is a critical step to ensure your eligibility for our training program.

Admission Procedure:

Our admission procedure is straightforward and ensures that you are well-prepared for your pilot training journey.

Follow these steps:

Step 1: Obtain a Class I Medical Certificate.
Your first step toward obtaining your pilot license is to pass a Class I medical certificate examination conducted by an Aviation Medical Examiner (AME).

Step 2: Enrollment Fee Payment: Upon receiving your medical certificate, you can proceed to make your enrollment fee payment of \$750.00.

Step 3: Document Submission: Once your enrollment fee payment is completed, we will need the following documents scanned together in a single email to fly@avelflightschool.com.

1. A completed Application Form
2. Completed Start Date Form
3. A receipt of the wire transfer for the enrollment fee payment (provided by your bank upon completing the transaction).
4. Proof of Citizenship: Photograph of your current passport (valid for at least 12 months from the date of enrollment)
5. Proof of legal residence, Utility bill / bank statement / legal ID with home address / housing lease.
This documentation is crucial to fulfil Transportation Security Administration (TSA) requirements.

Following these steps ensures a smooth admission process, and you'll be well on your way to starting your pilot training.

Admission Confirmation:

After receiving and verifying your documents and confirming payment, we swiftly complete admission formalities including issuing the I-20 and Letter of Admission required for your M1 student visa approval. A soft copy of these documents will be emailed to you. After we receive your confirmation, verifying the accuracy of the draft soft copy details, the original soft copy will be emailed to you.

Tuition Fees Payable:

You will only be required to pay the tuition fees once you have obtained your visa.

Payment Procedure After Receiving Your Visa:

Upon making your payment, please send us the following information in a single email at least 2 weeks before your arrival in the US:

1. Wire transfer receipt of Tuition fees (provided by your bank upon completing the transaction)
2. Flight Details
3. Copy of Visa

Failure to provide this information in the specified format at least 2 weeks before your arrival in the US will result in the cancellation of your I-20.

Following this, you'll promptly be scheduled with an instructor, and your ground school and flight lessons will commence immediately after TSA formalities. Non-citizens require Flight Training Security Program (FTSP) approval to initiate flight training.

Accommodation: All accommodations and transportation expenses are your responsibility for the entire duration of your stay in the U.S. We will provide you with a list of recommended places to stay in the arrival formalities attachment. This attachment will be sent to you in a separate email after you have received your visa and sent us a copy. Please note that accommodations are subject to availability.

Airport Pickup

Upon your arrival at Chicago, airport pickup services are available for an additional fee of \$120
